Rights of the Data Subject

Pursuant to article 11 of Law, by applying to our Company, you have the right **(i)** to be informed about whether their personal data is processed or not, **(ii)** in case if your personal data is processed, to request information regarding the process, **(iii)** to be informed about the purpose of processing your personal data, and whether it is used in accordance to the stated purpose, **(iv)** to become familiar with the third persons to which your personal data is transferred at home or abroad, **(v)** to request correction of your personal data, if it is processed deficiently or improperly, **(vi)** to request deletion/destruction of your personal data within the framework of the provisions prescribed in Law, **(vii)** to request notification of requests for deletion and destruction of personal data or request of correction of personal data as per Law to third parties to which your personal data is transferred, **(viii)** to object to any unfavorable result arising due to analysis of processing your personal data by only automatic systems, and **(ix)** to request for indemnity, in case if you suffer a loss due to the fact that your personal data has been unlawfully processed.
